



Higher Education Emergency Relief Fund II Report – Emergency Financial Aid Grants to Students

Quarterly Report – As of March 31, 2022

Under the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA), Higher Education Emergency Relief Fund II (HEERF II), **Glendale Career College-Glendale, North-West College-San Diego, North-West College-Bakersfiled, and Nevada Career Institute (OPE ID 023385)** received education stabilization funds designated exclusively for emergency financial aid grants to students.

Pursuant to guidance issued by the Department of Education through an [Electronic Announcement](#) published on May 6, 2020, we are providing the following information about the funds we have received, and how, and to whom, we have distributed them.

1. On 03/01/2021, the institution signed and returned to the Department of Education the *Recipient's Funding Certification and Agreement - Proprietary Institution Grant Funds for Students* which is required to receive funds allocated under Section 314(a)(4) of the CRRSAA. The institution will use 100% percent of the total funds received for emergency financial aid grants to students.
2. The total amount of funds that the institution has received from the Department of Education pursuant to the institution's Certification and Agreement specifically for HEERF II is **\$1,755,302**.
3. The total amount of HEERF II grants distributed to students under Section 314(a)(4) of the CRRSAA as of the date of this Fund Report is **\$1,104,300**.
4. The estimated total number of students at the institution who may be eligible to receive HEERF II funds under Section 314(a)(4) of the CRRSAA, as of the date of this Fund Report is **1,211**.
5. The total number of students who have received a HEERF II grant under Section 314(a)(4) of the CRRSAA as of the date of this Fund Report is **1,211**.
6. The methods we used to determine which students receive HEERF II grants and how much they would receive under Section 314(a)(4) of the CRRSAA are included below under "Student Emergency Funding Allocation".
7. The information we provided to students concerning the HEERF II grants appears below under "Student Notices".



Student Emergency Funding Allocation

Student eligibility for Phases One through two of the emergency grants was established as follows:

Phase One: The College used the following criteria to identify the Phase One cohort of eligible students:

1) All active students who were attending courses as of 04/30/2021, and 2) who are eligible to receive Federal Pell Grant Funds with a valid Student Aid Report.

Each eligible student was provided a **\$500** grant in Phase One.

Phase Two: The College used the following criteria to identify the Phase Two cohort of eligible students:

1) All active students who were attending courses as of 08/31/2021, and 2) with a zero EFC in the Student Aid Report.

Each eligible student was provided a **\$700** grant in Phase Two.

Phase Three: The College used the following criteria to identify the Phase Three cohort of eligible students:

1) All active students who were attending courses as of 11/30/2021, and 2) with a zero EFC in the Student Aid Report.

Each eligible student was provided a **\$700** grant in Phase Three.

Phase Four: The College used the following criteria to identify the Phase Four cohort of eligible students:

1) All active students who were attending courses as of 03/15/2022, and 2) with a zero EFC in the Student Aid Report.

Each eligible student was provided a **\$700** grant in Phase Four.
